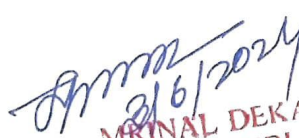
That the school will not coerce any student parent to buy books stationary/uniform from any particular shop.

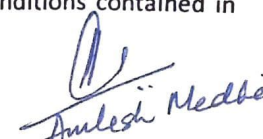
That the school shall strive to make efforts for conservation of environment.
